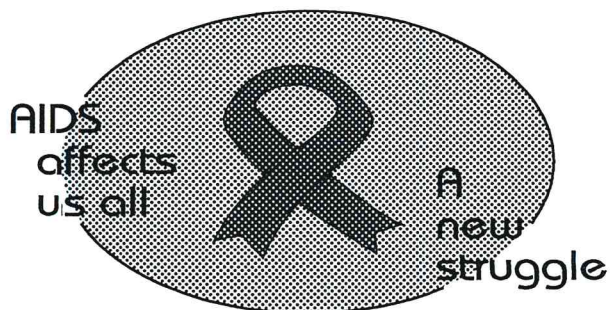

The Member of the Executive Council has, in terms of section 85, read with item 2(8) of Schedule 1 of the Limpopo Gambling Act, 2013 (Act No. 3 of 2013), amended the Limpopo Betting Regulations that were published in *Government Gazette 1977*, Notice No.255 of 9 September 2011 and amended by *Government Gazette 2328*, Notice No.2 of 14 March 2014, as set out in the Schedule.

**SCHEDULE****1. Definitions and Interpretation**

In these Regulations "the Regulations" means the regulations published in *Government Gazette 1977*, Notice No. 255 dated 9 September 2011.

**2. Amendment of regulation 1**

Regulation 1 of the Regulations is hereby amended by the substitution for the definition "**gross betting revenue**" of the following definition:

"**gross betting revenue in relation to bookmaker**", means hold less take out,

- (a) "hold" in respect of an event or contingency, means the total of all punters stakes in bets laid by the bookmaker in respect of such event or contingency, less the total stakes of all take back bets placed by the bookmaker on such event or contingency; and

- (b) "take out" in respect of an event or contingency, means the total amounts paid by the bookmaker to winning punters in respect of that event or contingency, less all amounts received by such bookmaker in respect of take back bets placed by the bookmaker on such an event or contingency;

"gross betting revenue in relation to totalisator" means the gross takings less any dividends distributed to punters;"
